If you arrange a Direct Cremation, you can use an Alternative Container. Alternative Containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering (the container we provide is a fiberboard container.)

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. **However, any funeral arrangements you select will include a charge for our Basic Service Fee and Overhead.** If Legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**GREEN BURIAL** is the caring for the dead with minimal environmental impact that aids in the conservation of natural resources, reduction of carbon emissions, protection of worker health, and the restoration and/or preservation of habitat. GREEN BURIAL necessitates the use of non-toxic and biodegradable materials, such as caskets, shrouds, and urns.

All CASKETS, SHROUDS and URNS must be constructed from plant-derived, recycled plant-derived, natural, animal, or unfired earthen materials, including shell, liner, and adornments. Fasteners and handles (other than those made from brass or chrome) are excluded from this requirement.

**HOME FUNERALS** are when a loved one is cared for at home after death, by family, giving them time to gather and participate in:

- planning and carrying out after-death rituals or ceremonies
- preparing the body for burial or cremation by bathing, dressing, and laying out for visitation
- keeping the body cool with noninvasive techniques, such as ice
